HOW WILL THE 2024 BUDGET AFFECT ME?

Total projected revenues for 2024 are \$267.7 million with 57.9% coming from property taxes and 21.8% from user fees. The amount of municipal taxes you pay depends on your property type and your property's assessed value.


The City's budget includes a 7.7% increase in taxes on the average home in the City which includes 1.0% for asset management.


